Instructions for Amended Tax Return Filers** - Tax filers who have amended their 2018 tax return can use the IRS DRT to load their tax information into the FAFSA, but they will still need to provide the Shelton State Community College's Enrollment Services Office with a signed copy of the 2018 1040X filed with the IRS.
- I. Instructions for Victims of IRS Identity Theft** - If you are unable to obtain an IRS Tax Return Transcript due to identity theft, please call 1.800.908.4490. You will be able to obtain an alternative document (TRDBV) acceptable for verification. We will also require a signed statement by the tax filer verifying the IRS-related identity theft and proof that the IRS has been notified.
